Each shareholder will receive a Form 1099-DIV following the end of the 2024 calendar year, which will reflect the actual amounts of income, capital gain and return of capital paid by the Company, if any. The final determination of the tax attributes of our distributions is made annually as of the end of the Company's fiscal year. Such amounts will be taxable in calendar year 2024 and reportable on your 2024 federal and other income tax returns.
